ANNEXURE

Proposal for Mission 1000 Selection Criteria

The Mission 1000 initiative by Government of Kerala is aimed at scaling up 1000 Micro, Small and Medium Enterprises (MSMEs) in the State into businesses with average annual turnover of Rs. 100 crore in a span of four years. MSMEs will be selected through an objective and transparent process. The initiative will create an environment of growth and development for the MSMEs in Kerala by providing a unique opportunity for them to scale up their businesses and reach new heights of success.

For being eligible for applying to the Mission 1000 scheme, the MSMEs shall satisfy the following prerequisite criteria:

- MSME should be registered in Kerala with valid UDYAM registration
- MSME unit must be in operation for at least three years as of March 31, 2023, and
- MSME must be engaged in manufacturing or service activities (units engaged in trade activities are not eligible)

Selected units will be provided with various incentives to encourage their growth, such as

- Capital Investment Subsidy of 40% limited to Rs. 2 Crore
- Interest subvention for working capital loans 50% of the interest rate limited to Rs.50 Lakh for a period of 4 years from the date of approval of DPR
- Financial assistance for preparation of DPR up to Rs. One Lakh per

Enterprise

• One to one hand-holding by assigning an officer from the Industries Department to each selected enterprises to assist them in their various scaling-up related activities.

Application process and ranking criteria

An online portal (www.mission1000.industry.gov.in) is developed for MSMEs to apply for being selected under the initiative, and a scoring-criteria based on information submitted on the portal will be used to identify the top 1000 units for the project.

- MSME units satisfying the pre-requisites can apply by registering in the online portal.
- The applications submitted would be verified at concerned IEO and ADIO level. The verification would include checking for correctness of information and the supporting documents submitted.
- Applications thus verified would be recommended by the concerned General Manager of District Industries Center to the Director of Industries and Commerce.
- The recommended applications would be scored and ranked based on pre-defined criteria given below

The scoring criteria comprises of the following:

1. Quantitative Parameters

- a. Whether belonging to Priority Sector Industries identified in Kerala Industrial Policy 2023
- b. Annual turnover as of 31st March 2023
- c. Average YoY Increase in Turnover during FY 2020-21. FY

2021-22 & FY 2022-23

- d. Average YoY Increase in Net Profit during FY 2020-21, FY 2021-22 & FY 2022-23
- e. Export Turnover (highest in FY 2020-21, FY 2021-22 & FY 2022-23)
- f. Average YoY Increase in Investment during FY 2020-21, FY 2021-22 & FY 2022-23
- g. Capacity Utilization as of 31st March 2023
- h. Availability of spare infrastructure and/or land for future expansions
- i. Regularity of loan accounts & credit history
- j. CIBIL score of promoters
- k. Quality Certifications obtained by the unit
- 1. Current Ratio as of 31st March 2023
- m. Salary to Turnover Ratio as of 31st March 2023
- n. Average YoY Growth in total Employment during FY 2020-21, FY 2021-22 & FY 2022-23

II. Qualitative Parameters

- a. Whether the applicant unit has a vision for scaling up the business?
- ь. What are the plans for diversification/expansion/

modernization?

- c. What is the market expansion strategy?
- d. Whether the unit has any plans for strategic tie ups/collaborations?
- e. What are the plans for new technology integrations?

The applications would be scored and ranked based on the above quantitative and qualitative criteria.

Approval Committee

The applications that are ranked would be shortlisted based on the predefined cut-off marks. A State Level Approval Committee will approve the shortlisted applications. The structure of the State Level Committee is proposed as follows:

The MSMEs in the first 1000 ranks would be selected for assistance under the Mission 1000 scheme.
