ORDER

As per Government Order read as 1st paper above Government have ordered that 33% of the post of the Junior Superintendent will be on the higher grade in the scale of RS.50,200/- - 1,05,300/-. Accordingly higher grade promotion has been sanctioned to Sri. Pratheesh Kumar K(Serial No. 35) in the seniority list of Junior Superintendents published vide proceedings read as 2nd paper above. As per proceedings read 3rd above 2 Junior Superintendents (Higher Grade) ie., Sri.Harikumar R S and Sri.Anil Kumar R have been promoted as Senior Superintendents. Hence, there are 2 vacancies of Junior Superintendent Higher Grade at present.
