The Committee shall take note of export figures and review them to ascertain and sort out issues facing exporters from the State.

The Committee shall also be responsible for approving investments under the ASIDE Scheme and its successor TIES.

The Committee will act as an institutional mechanism for regular Co-ordination between the Department of Commerce, Government of India and the State Government for focusing on export issues.


The Committee will review all trade related issues, including issues of logistics, agriculture exports & service exports.
