<u>ORDER</u>

As per the Government Order read (1) above, State Level Executive Committee (SLEC) was constituted with Chief Secretary as Chairman for the implementation of activities of NBM in the State. Kerala State Bamboo Mission (KSBM) is designated as the Bamboo Development Agency (Nodal Department) with Director of Industries & Commerce as Mission Director - NBM.
