AMENDMENT PROPOSAL
(THE SCHEME FOR MARGIN MONEY GRANT TO NANO UNITS)

The following Clauses/Rules are amended as proposed against each

Para No 4	All newly registered Nano enterprises in manufacturing /food processing,excluding service sector units, whose total project cost including fixed capital and working capital up to Rs 10 lakh are eligible for assistance under this scheme. Annexure Objectives	The objective of the scheme is to promote/incentivize deserving entrepreneurs in setting up Nano enterprises within the state through Margin Money loan to Nano units for loan linked projects.	The objective of the scheme is to promote/incentivize deserving entrepreneurs in setting up Nano enterprises with in the state through Margin Money <i>Grant</i> to Nano units for loan linked projects.

Guidelines Eligibility	All newly registered, Nano proprietary enterprises in manufacturing /food processing and job works and units engaged in service sector having any type or value addition,whose project cost including fixed capital and working capital upto 10 lakhs are eligible for assistance under the scheme.	All <i>new nano</i> proprietary enterprises in manufacturing /food processing, <i>job works and units engaged in service sector having any type of value addition,</i> whose project cost including Fixed capital and working capital upto 10 lakhs are eligible for assistance under the scheme.
Entitlement last sentence	The units which commences with own contribution without availing Bank loan is also eligible for this assistance.	<i>(Delete the sentence)</i>
General provisions Para No 5	Industrial units which receive the assistance will be under obligation to remain working continuously for three years from the date of receipt of grant.However, it is necessary that a unit shall be a working one as on date of release of the assistance.	Industrial units which receive assistance will be under obligation to remain working continuously for three years from the date of receipt of grant. <i>(delete the 2nd sentence)</i>

- 3.Embroidery work and other ornamental trimmings.
- 4.Metal working service activities & repair of fabricated metal products.
- 5.Repair & Services of Computers & peripheral equipments, projectors, Mobile phones, TV, A/C, Video Cameras, Watches, Clocks, other electronic equipments & other household equipments.
- 6.Electrical welding &Soldering
- 7.Laundry Services/Dry cleaning
8. Photo copying
9. Repair & Servicing and alteration of Motor Vehicles and related parts and accessories.
10. Tyre retreading
11. Upholstery work
- 12.Repair & maintenance of boats, fishing boats, vessels and other floating structures
13. Repair and maintenance of structural products
- 14 .Repair and maintenance of pipes & pipelines
15. Repair and maintenance of metallic tanks, reservoirs,etc.
16. Repair of Machinery engines, pumps and related equipments.
17. Treatment & disposal of waste of all kinds
18. Other information service activities
19. Recycling
20. Workshop

The list is indicative not exhaustive. Similar activities in service sector having any type of value addition which is found eligible by General Manager, District Industries Centre are also be considered .
