As per the notification G.O(P)No.21/2024/ID dated 21.06.2024, the Provisional Seniority List in the cadre of Joint Director/ General Manager as on 31/12/2023 was published calling for objections. An objection from Sl.No.9 Sri. Sajith Kumar.K has been received within the specified time limit pleading that he shall be placed above Sl.No.8 Sri. Renjith C.O in the seniority list as his advice seniority in the entry cadre ie; Assistant Director is above Sri. Renjith C.O. Government had examined and rejected the same as per letter



No.A2/92/2022/IND dated 11/09/2023 on the fact that the promotion to the post of Joint Director is based on the seniority in the feeder category of Deputy Director and not on the advice seniority of the lower post of Assistant Director. Further the seniority of Sri.Renjith C.O. is above Sri. Sajith Kumar.K in the feeder category. Therefore his objection against the seniority list has been rejected.
