ORDER

As per the Government Order read as 1st above Government have ordered that 33% of the post of the Junior Superintendent will be on the higher grade in the scale of Rs.50200-105300. Accordingly higher grade promotion has been sanctioned up to Smt. Latha K (Serial No. 28) in the seniority list of Junior Superintendent published vide proceedings read as 2nd above. As per reference as 3rd above five Junior Superintendents (Higher Grade) ie, Smt. Padmakumari N, Smt. Minimol K, Sri. Rameez K U, Smt. Minimol N T, and Smt. Jyothi S were promoted as Senior Superintendent. Hence, there are five vacancies of Junior Superintendent Higher Grade at present.
