III. REVIEW OF SELECT LIST OF DPC (LOWER) 2020 FOR PROMOTION TO THE POST OF ASSISTANT DISTRICT INDUSTRIES OFFICER

The Departmental Promotion Committee 2020 (Lower) held on 29-9-2020 had selected and included Sri S. Jayesh in the select list for promotion to the cadre of Assistant District Industries officer from the feeder category of Senior Co-operative Inspector. Accordingly, he was promoted as Assistant District Industries Officer on 11-2-2021 vide proceedings No. DIC/12713/2018-ED3 of Director of Industries & Commerce. Sri S. Jayesh had a seniority issue in UD Clerk, Junior Co-Operative Inspector and Senior Co-Operative Inspector cadres. Thereafter Government had clarified that Sri S. Jayesh is eligible for getting seniority just above his immediate junior Sri K. Vinod Kumar in the UD Clerk seniority list and if eligible, should be given notional promotion to Junior Co-Operative Inspector and Senior Co-Operative Inspector cadre with effecting the same date of promotion of Sri K. Vinod Kumar. Hence his seniority in UD Clerk and Junior Co-Operative Inspector was reassigned. Subsequently his seniority in the cadre of Senior Co-operative Inspector was reassigned with retrospective effect and placed above his immediate junior Sri K. Vinod Kumar (Sl. No. 125) as 124(a) in the seniority list of Senior Co-operative Inspector for the period from 01-01.2007 to 31-12-2011.

The incumbent is eligible for retrospective notional promotion in the cadre of Assistant District Industries Officer based on the reassigned seniority in the cadre of Senior Co-operative Inspector.
