ORDER

As per the letter read above, Managing Director of the Kerala State Electronics Development Corporation Ltd.(KELTRON) has requested Government to issue Orders for changing conventional Tube Lights by Energy Efficient LED Tube Light in all Government buildings and to appoint them as Nodal Agency for supply of its own manufactured products.

Government have examined the matter in detail and are pleased to designate KELTRON as the Nodal Agency for supply of KELTRON's own manufactured products.

Government are also pleased to constitute a Price Fixation Committee comprising the following members, for fixing the price of the KELTRON's own LED Tube Lights to be supplied by KELTRON directly to all Government Departments/Public Sector Undertakings/Local Self Government Institutions/Autonomous Bodies, etc without following tender formalities.

The Joint Secretary to Government, Stores Purchase Department will be the Chairman and the Managing Director, KELTRON will be the convenor of the Price Fixation Committee. The eligible payment towards Sri.Hariharasubramanian, Cost Accountant will be met by KELTRON after negotiating a bilateral agreement for the same.

The Convenor (Managing Director, KELTRON, Thiruvananthapuram) of the Price Fixation Committee will take necessary steps for convening the meeting. The convenor will also take action to furnish details/price schedules to the members of the committee to finalize the price of the LED Tube Lights to be supplied to various Government Departments/Public Sector Undertakings/Local Bodies/Autonomous Institutions etc. The convenor will also have to furnish a report to the Stores Purchase Department in the matter, within a short period of time after the meeting, so as to enable Government to issue Orders with the approved price lists.

The Technical Expert from the Industries and Commerce Department, Thiruvananthapuram will inspect and report to Government about the quality of the product. The representative from the Economics and Statistics Department will furnish to Government the market price of the product.
